Kellie Sue John was born on February 8, 1955 in Kearney, NE to Melvin and Beulah John. She grew up in the Sumner/Miller area and enjoyed her youth with her brother, Dan on the John Angus Farms. She graduated from SEM High School in 1973.

Kellie dedicated 52 years of service to Buffalo County. Her career began in the surveyors office in November 1973 until September 5, 1978. She then started working in the Register of Deeds office where she worked as an Abstract Clerk through 1984. In January of 1985 she was appointed as Deputy Register of Deeds. In January of 1999 she took oath and became the Register of Deeds of Buffalo County and held that office until the time of her passing. She fulfilled this roll with pride, demonstrating an extraordinary work ethic and strong belief in the importance of the oath that she took. If Kellie did something for you, you could relax knowing it was done to perfection!

Kellie lived a life defined by dedication to her faith, family, and friends. She was an active member of the St James Catholic Church and served as a volunteer in the ministries and committees of the church. She was creative, loved the color blue, enjoyed collecting angels, doing calligraphy projects for others and decorating her home with art pieces of faith. She enjoyed life's simple pleasures...sharing a good glass of wine with her loved ones, traveling, music, and especially watching her nieces and nephews activities, and caring for her parents and family. She had a remarkable gift of making others feel special, important, and loved. Receiving a gift from Kellie was like getting two gifts...one was the beautiful way it was wrapped and the second was that you knew the meaningful gift inside was chosen specifically for you. Kellie was a strong presence in Buffalo County and the community, serving in a multitude of organizations and touching countless lives. She was a member of the Nebraska Association of County Clerks, Register of Deeds and Election Commissioners (NACREC); NIRMA; and NACO where she held many various positions, too numerous to list. One of Kellie's greatest accomplishments was being instrumental in the implementation of the learning management system for the Register of Deeds. Kellie was active in the community serving in the following organizations; United Way, Buffalo County Legal Secretaries, Chamber Of Commerce, Kearney Catholic High School, MONA, Trails and Rails Museum , Crane Theater, Habitat for Humanity, Buffalo County Community Partners and P.E.O.- EG.

She is lovingly remembered by her mother, Beulah of Kearney; brother, Dan (Pam) John of Miller, NE; nephews & nieces, Eric (Stacy) John of Miller, NE.; Stacia Tallon of Hill City, SD, Lexie John of Rapid City, SD.; Clinton John of Miller, NE.; great-nephews and nieces, Deric and Isaac John of Miller, NE., and Grace John of Laramie, Wyoming.; Taylor, Brody, and Maddy Tallon of Hill City, SD. and many extended family members and friends. She was preceded in death by her father, Melvin in 2022.

Although we grieve the loss of Kellie, we know she is now at peace in the presence of the Lord and more than likely having some ice cream with her

dad while they play a game of cards. As she told many before her passing, “ I am not afraid to die, but I sure do hate to leave all those that I love behind. In heaven there will be no more pain, no more suffering, no more tears, it is going to be glorious!”

Over the years we have remained good friends, although I would not say that was always the relationship. Kellie was always much more mature than I, and dare, I say all the boys in my class while attending school. Often I would do something silly and Kelly could be seen rolling her eyes, which I am sure was appropriate. However, there were times when Kellie would let down her guard and come down to my level. One of those times was after play practice during our senior year when I, Connie Shelden, and Kellie were in Kellie's brother, Dan's car (I do not know why Dan allowed her his car), and we found ourselves in a local Sumner hayfield and more precisely Kellie found a haystack in that Hayfield. I will not go into anymore details, but we laughed about that incident throughout many years. I, along with our SEM classmates will never forget the all-night graduation party at Kellie's house, hosted by her parents, Melvin and Beulah John. After graduation we both ended up in Kearney and both played softball. Kellie was a great softball player as a catcher and played for many years garnering many accolades. In the 1984-86 era I attended UNO in Omaha and was researching and writing a paper on the settlement of Buffalo County, Nebraska. Kellie had earlier started working at the Register of Deeds office and when back in the Kearney area I did quite a lot of original deed searches. I always contacted Kellie and she always had everything prepared for me in my searches. I continued to do occasional local historic searches like that over the past 40 years and Kellie always had the deed books ready for me upon my arrival. After moving to Virginia, when I visited family and friends in Nebraska, I usually always stopped by to see Kellie as I always knew where she would be during the working week days, in the Register of Deeds office. From there she would aid me in planning reunion dinner dates with our classmates and other things. She was always professional and I always treasured our friendship. I also want to recognize and Thank a longtime friend and school classmate, Rhonda Richards, who was Kellie's best friend coming out of our school days and remained so.

Rhonda stayed with Kellie in Kearney after learning of her medical condition and remained by Kellie's side through to her passing. It is rare to find such a friend to be there in that most important time of need. Thanks Rhonda for aiding Kellie during that difficult time and also thanks to Kellie's neighbor Gay Warner for helping with Kellie as you did. Kellie, your passing creates a vacancy which can not be replaced but it also serves recognize the importance of friends in our life and to cherish every moment.
